1) From Quebec

Re: Bylaw 7:03

Original Wording:

All lifters must qualify within two years prior to the dates of their respective National Championships.

Proposed Wording:

All lifters must qualify within one year prior to the dates of their respective National Championships."

Reason: none provided

All lifters must qualify for their respective national championships not earlier than January 1 of the previous calendar year, excluding the previous nationals.

2) From Alberta

Re: . ARTICLE II: OFFICIAL LANGUAGES:

Original Wording:

The official language of the C.P.U. is English. All publications, meetings, and correspondence of the C.P.U. shall be written or conducted in English. Representatives of affiliated provinces may speak their mother tongues at national meetings but they must provide interpreters to render English translations.

Proposed Wording:

The official language of the I.P.F. is English; therefore, all C.P.U. national meetings with both anglophone and francophone attendees with be conducted in English. Representatives of affiliated provinces may speak their mother tongues at national meetings but they must provide interpreters to render English translations. CPU publications, namely the CPU website and the CPU constitution shall be available in both official languages.

3) From Alberta

Re: ARTICLE XVI: AFFILIATION REQUIREMENTS:

Original Wording:

2. Each province must have at least three provincially-certified referees, who have passed both a written and a practical examination.

Proposed Wording:

2. Each province must have at least three provincially-certified referees, who have passed both a written and a practical examination. The provincial federation shall supply provincially-certified referees with ties that indicate the referees province of origin.

Reason:

Would make referees appear more professional as well as an easy indictor of what provincial federation certifies them. Would like to aim for implementation by January 1st, 2010

6) From PEI

Re: Bylaw 3. RECORDS, AWARDS, AND CLASSIFICATIONS

Original Wording

3:08 The C.P.U. shall maintain a special award called the BILL JAMISON AWARD, which will be presented at the next appropriate national championship. This award shall he presented to the member who best exhibits sportsmanship, perseverance, and dedication to the sport of Powerlifting. The winner or this award shall be selected by 2/3 majority of the C.P.U. Executive Council. This award will not necessarily be presented each year, if no suitable candidate can be chosen and recipients may only receive this award one time.

Proposed Change:

3:08 The C.P.U. shall maintain a special award called the BILL JAMISON AWARD, which will be presented at the next appropriate national championship. This award shall he presented to the member who best exhibits sportsmanship, perseverance, and dedication to the sport of Powerlifting. The winner or this award shall be selected

by 2/3 majority of the C.P.U. Executive Council. This award will not necessarily be presented each year, if no suitable candidate can be chosen. (deletion of last part)

Reason: none provided

7) From Mike Armstrong

Re: Bylaw 7:04, Qualifying totals

Original Wording:

"A lifter may qualify for masters competition by lifting at an open event, the required qualifying total or single lift, within one year before achieving the minimum age requirement as a master."

Proposed Change:

A lifter may qualify for their next higher age category by lifting at an open event, the required qualifying total or single lift, within one year before achieving the exact specified age for the category.

EG: 39^{th} birthday for 40 - 49, 49^{th} birthday for 50 - 59, etc.

Reason:

A lifter who turns 40 late in a year has been able to qualify since January 1 of the year before, while they may have been just an early 38 years old. This may give them an unfair advantage.

8) From Mike Armstrong

Re: Article XIX, National Records

Proposal:

Add new item 3 c)

If a lifter sets a national record on one lift, with properly ranked referees, and a total record is also set by the lifter, the total record will be accepted, regardless of whether the referees for the non-record lift were correctly ranked.

If a total record is surpassed, but no other single lift records were set, and at no time were national or higher ranked referee's used, the total record will not stand.

Reason:

It has occurred that a lifter will set a single lift record using substitute national referees for that lift, then be told that his total record cannot stand because there were incorrect referees for the other lift(s). Often the lifters are unaware that this may be required because those lifts were not records, or that they may even be in contention for a total record.

2nd - AB - Motion Failed

9) From Louis Levesque

Article III.8 (National meetings)

Original Wording:

To constitute a quorum at any National Meeting, representatives from at least 50% of the affiliated provinces must be present.

Proposed Change:

At Nationals Meetings, excluding the AGM, quorum will be constituted with members present

Reason:

With the size of this country, this could eventually cause a problem. Although it never happened, but just in case.

2nd - Jeff - Motion passed

10) From Louis Levesque

Article V.3 (Executive council and officers)

Original Wording

At National meetings and in other circumstances requiring a vote, voting shall be limited to the members of the executive council.....

Proposed change:

At National meetings and in other circumstances requiring a vote, voting shall be limited to the members of the executive council **or a delegate of the province who's President is absent...**"

Reason:

We have delegates voting every year instead of the Provincial Presidents

2nd - Mike Armstrong - Motion passed

11) From Louis Levesque

Re: Article XIX, National records:

I don't think we have a rule that states that you must have 2 National referees for all lifts for a Total record being granted. Maybe it should be added

Proposal: National records in the total will only be accepted if the correctly ranked national referee's were used on all successful lifts, regardless of whether they were single lift records, with the same requirements as for single lift records.

2nd - AB - Motion passed

12) From Louis Levesque

Re: Bylaw 4.04

Bylaw 2, Finance, list the sanction fee for National Championships as \$500, yet bylaw 4:04, regarding national championship bids, states: "...accompanied by a certified cheque or money order in the amount of \$75.00, as payment of the sanction fee..."

Reason: Housekeeping, to correct an oversight

13) From Ontario

Re: National Championship's Scheduling

Proposal:

That future Nationals be started a day early with the Banquet on Saturday Evening.

Reason: People can make their way home on Sunday and return to work at the start of the following week.

Note: There is no specific day range required according to the bylaws, Bylaw 4, Competitions, only states "between March 15 and April 15". Article III, states the AGM shall take place "on the Wednesday immediately prior to the NATIONAL CHAMPIONSHIPS."

14) From Jeff Butt

Re: Bylaw 3.06, Awards

Original Wording

Where a Champion-of-Champions Award is to be presented, the winner shall be selected from among the class-winners.....

Proposed Wording

Where a Best Lifter Award is to be presented, the winner shall be selected from all lifters.....

Reason:

To be consistent with IPF policy, recently changed.

2nd - QU - Motion passed

15) From Jeff Butt

Re: Bylaw 3, Awards

Proposal to insert new bylaw 3:06:

At the annual Bench Press National Championships the award for the Best Male Bench Press (by Wilks Formula) shall be known as the Bill Jolley Memorial Award, in recognition of an exemplary CPU member who passed away in 1997. (Re-number subsequent bylaws)

Reason:

This reflects current practice of the last 10 years or so, as voted on by the EC, but never recognized in the bylaws.

2nd – Jeff Butt - Motion Passed

16) From Mike Armstrong

Re: Bylaw 8.0, Doping Controls

Proposal to insert new bylaw 8.08:

Should the new national record(s) set by a lifter in any category also be IPF World records, the Record Application fee mentioned in 8.05, 8.06, or 8.07 above, shall be waived.

Reason:

Some small recognition of the accomplishments of our members at the world level.

2nd - AB - Motion passed

17) Article 3 / Bylaw 4 - National Records

Change wording to "day prior" rather than "Wednesday" for the AGM

2nd AB - Motion passed
